Top Ten/Awards Report

- B. DCRP never sent the corrected relays in from their January meet so those times will not be reported to the USMS National office.
- C. DCAC/DCRP never sent in the official documentation from their meet last summer for the relays which broke USMS World Records. Therefore those relays will not get credit for their records.
- D. Short Course Meters awards have been calculated. Awards will be mailed.

Officials

- USMS may change a rule which would require more certified officials to be on deck at meets. Most likely this rule would be phased in.

Old Business

A. Convention delegates:

1. Debbie Morrin, Rob Whitters and Joann Leilich will represent Potomac Valley.
2. Dave Diehl & Lynn Hazlewood will be going as at-large delegates.
3. Budget shall be \$600 per person (this shall include the \$75 registration fee)

Motion: Approve the budget in item 3 above. *Passed.*

B. Rule change proposals at the Convention:

1. Change SCY relay age groups to be cumulative age (to be consistent with meters).
2. National Qual Times (NQTs): relax slightly.
3. Altitude adjustments for NQTs: use table in USS rule book.
4. Eliminate the 3 free events at Nationals (free as in not having to meet NQTs).
5. Eliminate enforcing the NQTs (leave it to the honor system rather than having to prove your times).

New Business

A. Are there any former US Olympians in the PV region other than Jeff Kostoff?

B. Question whether to send Ann Svanson to the National Convention as a PV delegate even though she no longer lives in the area? Answer - No, since she is no longer an active participant in PV activities.
