Last Meeting's Minutes - Changes

Report from Convention:

Meets:

- 1999 Short Course Yards Colonies Zone Meet will be hosted by Terrapin Masters at UMCP (May 1999).
- 1999 Short Course Meters Colonies Zone Meet will be hosted by either New England Masters or Garden State Masters in the Fall.
- 2000 Short Course Yards Colonies Zone Meet will be hosted by the International Swimming Hall of Fame, Ft. Lauderdale, as a Colonies/Dixie Zone Showdown.
- 2000 Short Course Nationals will be hosted by the Phoenix Swim Club, Phoenix, AZ, May 11-14.
- 2000 Long Course Nationals will be hosted by Maryland Masters, UMBC, Catonsville, MD, August 17-20.

Rules Change:

102.2 Age Determining Date

- A. For Short Course Yards, the eligibility of a participant for a particular age group will be determined by the age as of the last day of the meet.
- B. For Short Course Meters and Long Course Meters, the eligibility of a participant for a particular age group will be determined by the age as of December 31<sup>st</sup> of the year of competition.

USMS Sponsors:

- Mindspring.com is the Internet "provider of choice" for USMS.
- USMS receives credit if you mention USMS when signing up.
- There is a "Bookstore" link on the USMS Web site to amazon.com. If you enter through USMS and make a purchase, USMS will receive a percentage (a greater % if it is one of the swimming books listed on the USMS site).

Treasurer's Report:

- Newsletter expenses have been running slightly higher.
- Convention airfare expenses have been lower than usual.
- As of today, there is \$19,500 in savings; \$1,000 in checking.
- Convention expenses have been paid.

### Registrar's Report:

- 1999 Registration Forms were given out.
- If you would like mailing labels for your team, send a request and a SASE to Jeff Roddin.
- The 1999 Registration Form will be available in PDF format on the website after November 1.
- If you would like a roster of individuals who have registered as members of your team, with USMS, send an email to Jeff Roddin.
- USMS has a video which can be used to advertise Masters Swimming on TV. We are considering airing the video on a local station.

### Report from Convention:

#### Membership/Registration:

- Get your team involved with the county government and get the government involved with your team. Invite a mayor to your practice to give an award to one of your swimmers. Make a \$100 donation to a campaigning official.
- USMS National office has a publication, "Building a Successful Masters Club" available for \$6.
- Encourage local USS clubs to invite parents to join the kids in their workouts. Eventually enough interest may be generated to start a Masters Club.
- Get the word out about Masters Swimming to local cardiologists and swim apparel shops to build membership.
- This year USMS raised \$6500 for 2 charities: USMS Foundation & ISHOF through LMSC registration forms.
- Encourage a small club to host a national Postal meet to raise money for their club.
- USMS liability insurance coverage does not include any automobile coverage.
- Information is available at the USMS National Office on how to approach a local government about getting a new pool built.
- Clubs are asked to periodically check and update the USMS web site "Places to Swim" section.
- A Public Service Announcement video is available for \$75 and the final screen can be customized to have LMSC contact information included.

#### Competition:

- It is likely we will have Internet entries (with credit card payment) for 1999 Short and Long Course Nationals through the USMS web site.
- A motion was made to charge the USMS Officials Committee with a long-range goal of having USMS certified officials at our Nationals instead of USS officials. (Currently, there is no such thing as a USMS "official".)

### Sanctions Report:

- Margot presented a tentative schedule of next year's Potomac Valley meets.
- She has a form for meet evaluators that tells them how to run a meet.
  - A. Turkey Classic will be evaluated by Debbie Morrin.
  - B. DCRP meet will be evaluated by Jack Markey.
  - C. Albatross will be evaluated by Dave Diehl.

### Top Ten Report:

- Joann reported that at convention it was determined that there will be no change in the rule that, "A swimmer who wants to have a split time count for setting a record, should notify a meet official before swimming the event."
- Joann is establishing a Potomac Valley Top Ten listing for meters events. The goal is to eventually post it on the Potomac Valley web site. If anyone notes that a swimmer is inadvertently listed twice because of a change in name (getting married, divorced, etc.) let Joann know.

### Officials Report:

- Dave reported that there was discussion at convention, about how to certify USMS officials.
- Dave has a list of local USA Swimming certified officials who can officiate at meets.

### Other Business:

- Debbie Morrin, Chair, agreed to review the by-laws in order to determine if we need to elect a vice-chair. It's possible we can amend the by-laws to eliminate the position in Potomac Valley.
- Joann suggested that Potomac Valley donate \$1,000 to the USMS Foundation. The motion was passed.
